

# 2024-2025 Behavior Technician

## **GALS** Overview

GALS is an all-girls, public charter school serving ~300 students in 6th-12th grades. GALS provides a college preparatory education in a supportive environment that fosters the academic mastery and personal development necessary for every young woman to become a powerful advocate for herself and leader of her community. The school represents a standards-based response to the academic and social needs of girls+ in the Denver Public Schools (DPS). Classes incorporate an inquiry-based approach to learning and frequent movement that supports an active-based pedagogy.

### About the Position

GALS seeks to hire a Behavior Technician to provide front line, student facing support to coach students in positive school engagement. This position is a key first responder to student behavior escalation and provides tier I redirections and encouragement, and supports with tier II interventions and restorations, with students and community members.

#### **Responsibilities:**

- Serve as member of first responder team for teacher and staff support in redirecting or correcting negative student behavior that interrupts academic achievement
- Tier III first responder for students who are non-responsive to redirects with others
- Serve as point person for all immediate discipline concerns
- Implement behavior plans collaboratively developed by HOS, Student Coach, and potentially other support team members
- Implement behavior plans collaboratively developed by GALS team members
- Collaborate around design of interventions that support common responses to behaviors (example Tier III phone plan, consistent responses across consistent behaviors)
- Implement structures that support positive school habits
- Implement restorative practices like facilitated meetings/conflict resolution for arguments and social media conflicts and creation of behavioral contracts
- Coach students to be and stay in a positive emotional state in order to be in class
- Serve school duties in support of day-to-day school operations
- Participate in meetings and trainings as appropriate
- Other duties as assigned or requested by Heads of School or Character + Culture team members

## **Qualifications and Competencies**

- High School Diploma or GED
- · Ability to create positive relationships and rapport with students, families, and staff

- Adolescent/teenage champion
- Demonstration of an understanding, patient, and receptive attitude toward students of varied backgrounds, teen ages, and cognitive and social and emotional abilities
- Ability to maintain composure, calm, and patience under stressful conditions
- Ability to follow emergency procedures and protocols as determined by DPS and GALS
- Knowledge of basic child and adolescent development behavior characteristics
- Ability to implement behavior management techniques in a culturally responsive and honoring way
- Ability to effectively analyze situations to define issues and draw conclusions
- Willingness to work with students who have special needs and/or aggressive behavior
- Ability to de-escalate students proficiently
- Creative problem solving
- Ability to pass a background check
- Spanish proficiency preferred

#### Salary and Application Process

Full Time non-exempt position, following our paraprofessional pay scale and benefits, with starting pay based on years of relevant experience. The wage scale for this position is \$22.00/hour - \$32.62/hour.
